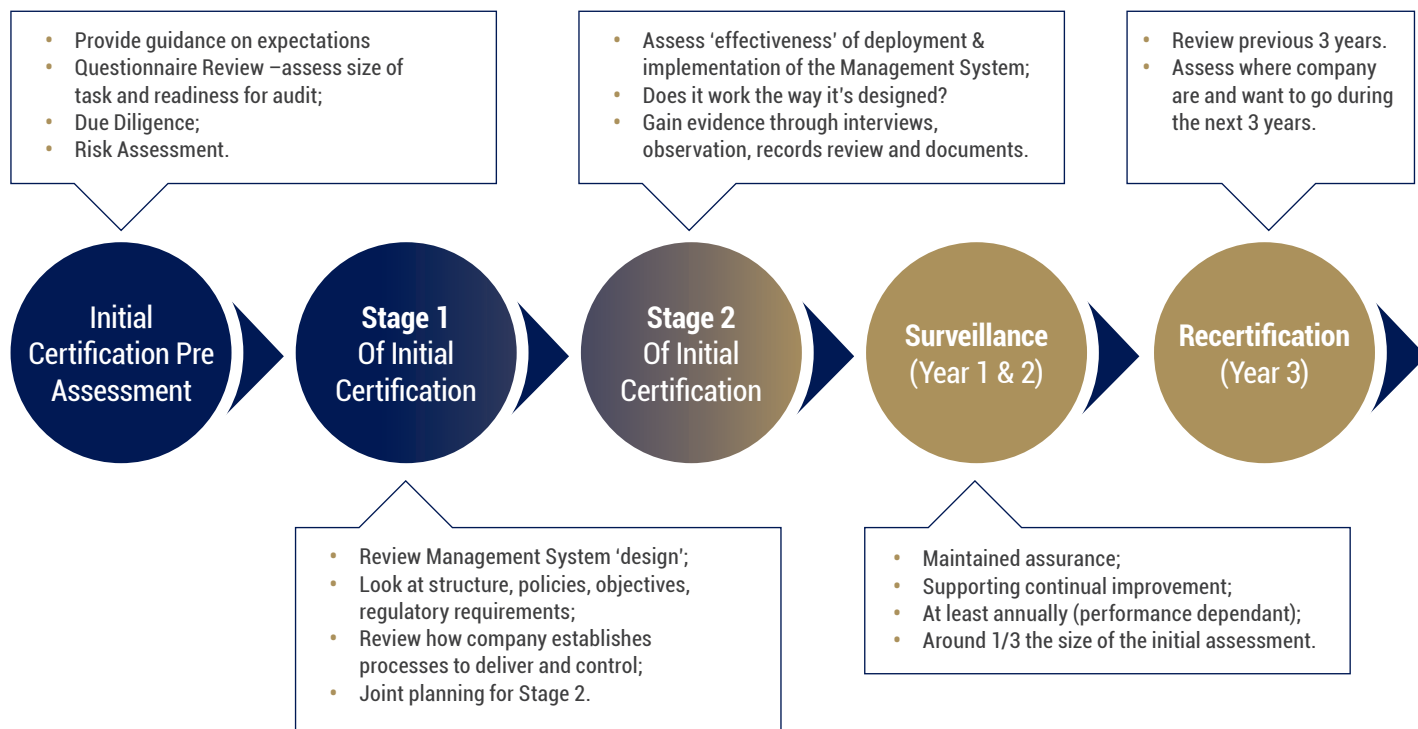

- A Supply Chain Security Management System (SCSMS) – with a risk based approach at its heart.
- If you already have ISO 9001 accredited certification then you are well on the route to success;
- ISO 28007 builds on ISO 28000 to help you design and implement your maritime security related management controls – including deploying armed guards;
- ISO 28007 cover key aspects of supply chain risk management; they place a strong onus on you as a security service provider to identify upon who and how your operation impacts, and who impacts you - from clients, to regulations and legal governance (for both you as a company, and those you deploy on task), through to employees and subcontractors (including selection, training and on-going competence), and include consideration of the UN Guiding Principles on Business and Human Rights;
- They encompass core security and supporting business functions, and your supply chain;
- Like any effective management control system, ISO 28007 need to be driven by the senior management team, and resourced.
